

Summary

May envelope giving exceeded the monthly budgeted amount by 40% due to the receipt of a full annual pledge. In accordance with the approved annual budget, \$8,800 was withdrawn from Legacy to fulfill our annual benevolence commitment to MACC (\$5,300) and the Greater Hartford Interfaith Action Alliance (GHIAA) (\$3,500). Year-to-date building maintenance is 3% over the annual budgeted amount. Thank you for your support in voting to fund the steeple repair from the Legacy fund and for individual donations. Special funds realized gains in the month of May almost wiping out the losses from the month of April.

Continuing Resolution CR1.04 regarding capital expenditures was updated as distributed. Changes were made to reflect increased costs and limited reliable, skilled vendors. A motion to change resolution CR1.04 as modified by the Finance Committee was passed.

A nominating committee update was received.

New Business

A gift for New Horizon Baptist Church was approved.

A scholarship gift for Campfield Heinrich was recommended by finance and approved by council.

Concordian of the Year nominations will be discussed at the June meeting.

With the price of groceries and personal care items increasing at a historical rate, the need is greater than ever. The following sermon is based on Mark 4:26-34. It was delivered by Lucy Taveras in Spanish and by me in English to Ministerio Nueva Creación on Sunday, June 16th. I hope you enjoy it.

Sermon title: The Kingdom of God

In today's gospel we hear of two parables told by Jesus to the crowds gathered around to hear him preach. In both, he is describing what the Kingdom of God is like.

The first is the parable of the growing seed and the second is the parable of the mustard seed. Both are about seeds, but each from a different perspective. A seed is a mature ovule that comprises an embryo or a miniature undeveloped plant and food reserves, all enclosed within a protective seed coat.

If a seed is planted in good soil and is nurtured with sunlight and water, it will grow into whatever kind of plant it is destined to be. We may put it in the sun and add the water, but it is God that makes it grow as part of his wonderful creation. If it's a fruit bearing plant or a vegetable, we can come and collect it at the time of harvest.

Isn't this similar to how we are born little babies and are clothed and fed by our parents or caregivers, and we learn and grow, and God expands our faith until the harvest time when we are collected and go up to heaven. That is the way of things.

Jesus points out the mustard seed is the tiniest of seeds but turns into the largest of bushes, so big that birds can perch in the shade of its branches. It doesn't matter how little or humble your beginnings are, with nurturing, faith, love, and God's guidance, you can achieve amazing things. We all have that little seed of faith that we can grow and in doing so we grow as people and can even move onto big things.

Nurturing is an important aspect in the growing of plants from a seed. If you don't water it, it will not grow. If it doesn't have the light and warmth from the sun, it will not survive. Similarly, what are the things that we do to nurture our own faith? You can replace water with the plants with the water from our baptism where we are reborn in faith everyday thanks to Jesus. That's the good news. Each day we have a chance to grow. We can forget the mistakes of the past and try again.

We can replace the heat and light of the sun with the holy spirit. Jesus, guiding us, and giving us the power we need to grow in our faith, and then using that faith to help ourselves and to help others. You never know if the smallest help you've given really made a difference in someone's life. That food & drink you provided to sustain life, that word of encouragement that kept someone down from harming themselves or others. That smile you gave to a lonely person that tells them they belong.

Of course, the greatest garden you can find is the church. Here are people committed to nurturing the seeds in their souls to grow in faith. Here you're in a field of growing plants, sometimes not all at the same speed, or to the same heights, but we are here together, basking in waters of baptism and the warmth and light of the holy spirit. Isn't it a wonderful garden? In church you can grow up through the soil and spread out roots below to keep you grounded in life. In church, you can grow from stem to leaves and flowers and expand your faith to provide room for others to perch in the shade of your branches. That is the kingdom of God.

Duties of the Congregation Council

(from Chapter 12 of Concordia's Constitution)

Note: On Sunday, June 30 members of the Congregation Council were installed during worship. These Council members have been elected to do the following on behalf of the congregation:

- C12.04 The Congregation Council shall have general oversight of the life and activities of this congregation, and in particular its worship life, to the end that everything be done in accordance with the Word of God and the faith and practice of the Evangelical Lutheran Church in America. The duties of the Congregation Council shall include the following:
 - a. To lead this congregation in stating its mission, to do long-range planning, to set goals and priorities, and to evaluate its activities in light of its mission and goals.
 - b. To seek to involve all members of this congregation in worship, learning, witness, service, and support.
 - c. To oversee and provide for the administration of this congregation to enable it to fulfill its functions and perform its mission.
 - d. To maintain supportive relationships with the rostered minister(s) and staff and help them annually to evaluate the fulfillment of their calling or employment.
 - e. To be examples individually and corporately of the style of life and ministry expected of all baptized persons.

- f. To promote a congregational climate of peace and goodwill, and, as differences and conflicts arise, to endeavor to foster mutual understanding.
- g. To arrange for pastoral service during the sickness or absence of the pastor.
- h. To emphasize partnership with the synod and church wide organization of the Evangelical Lutheran Church in America as well as cooperation with other congregations, both Lutheran and non-Lutheran, subject to established policies of the synod and the Evangelical Lutheran Church in America.
- i. To recommend and encourage the use of program resources produced or approved by the Evangelical Lutheran Church in America.
- j. To seek out and encourage qualified persons to prepare for the ministry of the Gospel.
- **C12.05.** The Congregation Council shall be responsible for the financial and property matters of this congregation.
 - a. The Congregation Council shall be the board of directors of this congregation, and as such shall be responsible for maintaining and protecting its property and the management of its business and fiscal affairs. It shall have the powers and be subject to the obligations that pertain to such boards under the laws of the State of Connecticut, except as otherwise provided herein.
 - b. The Congregation Council shall not have the authority to buy, sell, or encumber real property unless specifically authorized to do so by a meeting of the congregation.
 - c. The Congregation Council may expend up to 2% of the total budget in any calendar year for items, other than emergency repairs of building and facilities, not included in the budget. If, in the judgment of a majority of the Council members, an urgent need exists to repair any building or facility when there is insufficient time to call a Special Congregational Meeting under section C10.03 of the Constitution, the Council may expend for such repair up to 4% of the total budget. The Congregation must be informed within 5 weeks of this decision.
 - d. The Congregation Council shall prepare an annual budget for adoption by this congregation, shall supervise the expenditure of funds in accordance therewith following its adoption, and may incur obligations in excess of the anticipated receipts only after approval by a Congregation Meeting. The budget shall include this congregation's full indicated share in support of the wider ministry being carried on in partnership with the synod and church wide organization.
 - e. The Congregation Council shall ascertain that the financial affairs of this congregation are being conducted efficiently, giving particular attention to the prompt payment of all obligations and to the regular forwarding of benevolence monies to the synodical treasurer.
 - f. The Congregation Council shall be responsible for this congregation's investments and its total insurance program.
- **C12.06.** The Congregation Council shall see that the provisions of this Constitution, its Bylaws and the Continuing Resolutions are carried out.
- C12.07. The Congregation Council shall provide for an annual review of the membership roster.
- **C12.08.** The Congregation Council shall be responsible for the employment and supervision of the staff of this congregation. Nothing in this provision shall be deemed to affect the congregation's responsibility for the call, terms of call, or termination of call of any employees who are on a roster of this church.

New England Synod Assembly

Heading off to the 2024 New England Synod Assembly as a voting member of Concordia, I felt somewhat daunted by the task ahead ... electing a new bishop for the next six years! But, once in the company of Pastor Hedberg, Nancy Lynn Knauff, and Zachary Baranowski along with the Grace Lutheran delegation from Hartford, I not only felt more confident, but excited!

We were tasked with narrowing down the field of candidates through listening, questioning and prayerful consideration.

There was lots of work to be done and seemingly endless ballots to cast for a wide range of positions in addition to the election of Bishop

Hazelwood's replacement. I was reminded of Elizabeth Gilbert's book, titled "Eat, Pray,

Love." Our selection process could have been titled "Sing, Pray, Vote!", since prior to each vote we sang hymns to fuel the spirit and prayed for discernment - the ability to make sound decisions through spiritual guidance and understanding. We sought a candidate with a focus on worldly issues, specifically racial and social justice, spiritual devotion, and goals for our synod as it navigates the challenges of the future.



And then there were three: Pastor Sara Anderson, Pastor Marjo Anderson, and Pastor Nathan Pipho, all of whom were clearly groomed by God for this leadership role. (I would be remiss if I didn't give a big shout-out to Zach and Nancy Lynn for their technological assistance throughout this electoral process which relied heavily on tech know-how. For those of you who know me, this was a "biggie!")

It was wonderful to be a part of something so much bigger than myself! We worshiped and celebrated the Holy Eucharist with over 400 Lutherans from all

walks of life! Nancy, my sister Pam, and I sang in a pick-up choir with more than 100 other singers! We were inspired alongside voting members from Maine, Vermont, New Hampshire, Massachusetts, Rhode Island and Connecticut by the keynote speaker, Rev. Mark Alan Powell who spoke on Journeying with Jesus! Together, we stood strong! On Friday night, we all laughed and welled-up during the funny, yet heartfelt "Roast" emceed by our own Mark Winzler, paying tribute to the amazing, outgoing Bishop Hazelwood. As you probably have guessed, Mark did an outstanding job! David Smith (Concordia), Bea Santiago and Lucy Taveras (both MNC) were also at Assembly. David

and Bea facilitated The School of Lay Ministry graduation. I was proud to be a Concordian!

And finally we heard from our Bishop-elect, Nathan Pipho. I know he will serve Lutherans throughout the New England Synod with integrity, energy, conviction, and an undying love for "the story of Jesus." In conclusion, as reiterated by him throughout the assembly, "To God be the Glory!" ~*Bobby McKinney*

Gail is always present. She attends worship every Sunday and supports Concordia's activities. She is a quiet presence. She is not a person who stands up front and visibly leads, but rather


leads and is supportive from the outside.


Pastoral Care for July and August

Transition Update

During late April and May members of the Transition Team/Council visited four churches:

Manchester: North United Methodist and Center Congregational; Bolton: St. George Episcopal;

East Hartford: All Saints Episcopal; South Windsor: St. Peter's Episcopal. Two Concordia members attended worship (on different Sundays) at each of these churches.

Information received was reported out to a joint meeting of the Congregation Council and the Transition Team.

As a result of the discussions, the focus was to take the next step with North United Methodist, St. George's Episcopal and St. Peter's Episcopal.

At the end of June a letter was sent to the Pastor and lay leadership of each of the aforementioned churches inviting them (if they are interested) to a meeting with us initially to get to know each other and, to see where those discussions might lead in terms of sharing resources.

As of this writing (July 2), one response has been received from the Rector of St. Peter's in South Windsor indicating interest in an initial conversation just to gather additional information. Mark will meet with her on July 3. (Their Vestry does not meet until August.)
